In view of the submission made by the learned Additional Government Pleader, this writ petition cannot be maintainable and the same is liable to be rejected on the ground that the petitioner has approached this Court at premature stage. Accordingly, this Writ Petition is dismissed with liberty to the petitioner to challenge the final orders passed by the authorities in this regard, if any. No costs. Consequently, connected miscellaneous petition is closed.
