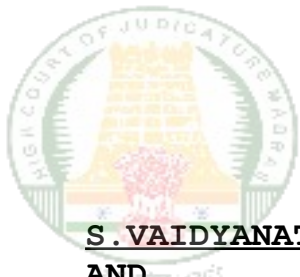

Challenge is made to the order of detention passed by the second respondent vide proceedings in Cr.M.P.No.40/2019 dated 01.08.2019, whereby the detenu, namely Mahendran, S/o Ramasamy, aged about 34 years, was ordered to be detained under GOONDA as contemplated Section 2(f) of the Tamil Nadu Act 14 of 1982.
