PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory bail in Crime No.189 /2019 on the file of the
respondent police.

ORDER

The petitioners, who apprehend arrest at the hands of the
respondent police for the offences punishable under Sections 147,
148, 294(b), 323 and 506(ii) of I.P.C., in Crime No.189 of 2019,
seek anticipatory bail.

2. Heard both sides.



3.The learned counsel appearing for the petitioners has submitted that the petitioners are innocent and they have been falsely implicated in the above case. He further submitted that the first petitioner also gave a complaint against the defacto complainant and others and the said complaint was registered by the respondent police under Sections 147, 294(b), 355, 323 of I.P.C and Section 4 of TNPWH Act in Crime No.192 of 2019. He further submitted that the petitioners have not committed any offence and therefore, he prayed for granting anticipatory bail to the petitioners.

4.The learned Government Advocate (criminal side) has fairly conceded that based on the complaint given by the first petitioner herein a case was registered against the defacto complainant in Crime No.192 of 2019 under Sections 147, 294(b), 355, 323 of I.P.C and Section 4 of TNPWH Act and also submitted that the injured persons have sustained simple injuries and they were already discharged from the hospital. She further submitted that both the cases are case in counter. He further submitted that the investigation is only at initial stage and hence, she strongly opposed this petition.

5.Taking into consideration of the fact that the counter case has also been registered in Crime No.192 of 2019 under Sections 147, 294(b), 355, 323 of I.P.C and Section 4 of TNPWH Act and also the fact that the injured persons sustained only simple injuries and they were also discharged from the hospital, this Court is inclined to grant anticipatory bail to the petitioners with certain conditions.

6.Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned Judicial Magistrate, Ambasamuthiram, Tirunelveli District, on condition that the petitioners shall execute a bond for a sum of Rs.10,000/- (Rupees ten thousand only) each with two sureties each for a like sum to the satisfaction of the respondent Police or to the Police Officer, who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

(i) If the petitioners fail to surrender before the concerned Magistrate within a period of 15 days, this order shall stand automatically cancelled.

(ii) the petitioners shall report before the respondent police daily at 10.30 a.m for a period of three weeks and thereafter, as and when required before the respondent police for interrogation.



(iii) the petitioners shall not tamper with evidence or witness either during investigation or trial.

(iv) the petitioners shall not abscond either during investigation or trial.

(v) On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

(vi) If the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
