PRAYER :-

For Anticipatory bail in Crime No. Not Known of 2019 on the file of the respondent police .

ORDER : The Court Made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under Sections 406 and 420 of I.P.C, in Crime No. Not known of 2019, seeks anticipatory bail.



2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondent. This Court heard the learned counsel for the intervenor also.

3. When the matter was taken up for hearing, the learned Government Advocate (Crl. Side) for the respondent submitted that the petition enquiry is pending against the petitioner. However, the petitioner shall appear before the respondent police daily at 10.30 a.m for a period of seven days. If the respondent intends to register an First Information Report against the petitioner, the respondent shall issue notice under Section 41 A of Cr.P.C. to the petitioner. This arrangement is directed so as to give breathing time to the petitioner to move this Court for the relief.

4. Subject to this direction, this Criminal Original Petition stands disposed of.
