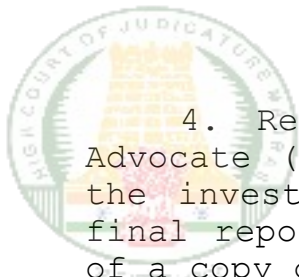

ORDER

This petition has been filed seeking direction to the second respondent to complete the investigation and file a final report in Crime No.55 of 2018 pending on the file of the second respondent.

2. The grievance of the petitioner is that based on the complaint given by the petitioner, a case in Crime No.55 of 2018 has been registered for the offences punishable under Sections 323, 324 and 506(ii) IPC by the respondent police on 27.05.2018. But so far, the respondent police has not taken any action on the said complaint. Hence, the petitioner has filed the present petition.

3. The learned Government Advocate (Crl.Side) would submit that the investigation on the complaint given by the petitioner is substantially completed and final report is ready and awaiting for the approval of the learned Additional Public Prosecutor.
