ORDER

The grievance of the petitioner is that seeking permission and protection to conduct cultural programme (i.e) Adal Padal Dance programme on 31.08.2019 in the above said temple, the petitioner made a representation on 16.08.2019 to the respondents and the said representation was not considered so far.
