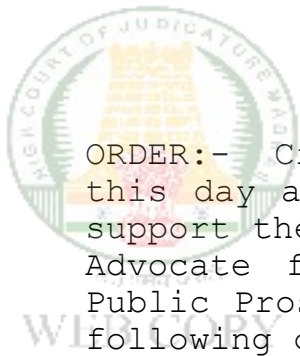

Petition praying that in the circumstances stated therein and in the petition filed therewith the High Court will be pleased to direct the respondents to temporary release the detenu by name Vethaiyan @ Ravi, son of Vembaiyan aged about 50 years, confining at Central Prison, Tiruchirappalli under preventive detention by the order passed by the respondent No.2 in C.O.C.NO.03/2019 dated 29.03.2019 for 15 days for attending his brother's daughter marriage and to take treatment 31.08.2019.

Prayer in Habeas Corpus Petition(MD) No. 343 of 2019 :

Habeas Corpus Petition praying that in the circumstances stated therein and in the affidavit filed therewith, the High Court will be pleased To calling for the records to relating to the detention order in C.O.C.No.03/2019 dated 29.03.2019 passed by the Second Respondent herein and quash the same and direct the respondents to produce the body of the person of the detenu namely Vethaiyan @ Ravi (48 years) S/o.Vembaiyan before this Honourable Court now detained under Sub Section (2) of 3 of TPDA Act 14 of 1982 in the Central Prison, Trichirappalli and set him at liberty.



ORDER:- Criminal Miscellaneous Petition is coming on for hearing on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.S.Palanikumar, Advocate for the Petitioner and of Mr.K.Dinesh Babu, Additional Public Prosecutor on behalf of the respondents, this Court made the following order:

It is reported by the learned Additional Public Prosecutor that the detenu has surrendered before the Central Prison, Tiruchirapalli on 03.09.2019, in compliance with the orders passed by this Court on 29.08.2019.

2. Recording the compliance, this Criminal Miscellaneous Petition is closed.

3. Post the main Habeas Corpus Petition on 26.09.2019, finally.
