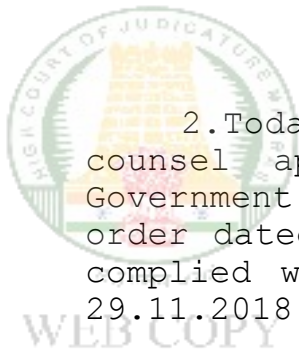
Prayer in WP(MD). 7015 of 2019 :
