PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

for Anticipatory Bail in Crime No.6 of 2019 on the file of the  
Respondent Police.

ORDER : The Court made the following order :-

Heard the learned counsel appearing for the petitioner and  
learned Government Advocate(Crl. Side) appearing for the respondent.

2.The petitioner apprehends arrest at the hands of the  
respondent for the offences under Sections 294(b), 323, 498(A) and  
506(ii) of IPC and Section 4 of Tamil Nadu Dowry Prohibition Act in  
Crime No.06 of 2019. He seeks anticipatory bail.

3.It appears that she attempted to commit suicide. In this  
regard, the petitioner's son was implicated as first accused. He  
was arrested and released on bail. Arresting the petitioner may not  
be served any purpose. Hence, anticipatory bail is granted.  
Accordingly, the petitioner is ordered to be released on bail in the  
event of arrest or on his appearance before the learned Judicial  
Magistrate No.I, Kovilpatti, Thoothukudi District and on his  
executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only)  
with two sureties each for a like sum to the satisfaction of the  
learned Magistrate concerned and on further condition that the  
petitioner shall appear before the respondent police as and when  
required for interrogation. The petitioner shall comply with the  
conditions related under Section 438 Cr.P.C. scrupulously.



4.The petitioner shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready, failing which, the petition for anticipatory bail shall stand dismissed.
