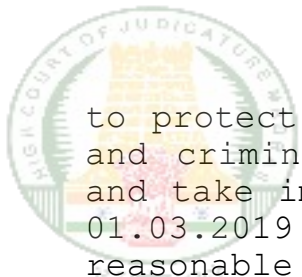

2. Heard the learned Counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent Nos.1 to 6.

3. The learned Additional Public Prosecutor appearing for the respondent Nos.1 to 6 based on the complaint lodged by the petitioner seeking police protection, an enquiry is under progress.

Considering the submission made by the learned Additional Public Prosecutor the sixth respondent is directed to conduct enquiry based on the complaint lodged by the petitioner, dated 01.03.2019, after issuing notice to the private respondents-7 to 18 and pass appropriate order, within a period of **Six(6) weeks**, from the date of receipt of copy of the order, in the light of the Judgment obtained by the petitioner before the Civil Court.

5. The writ petition stands disposed of with the above directions. However, there shall be no order as to costs.
