PRAYER :-

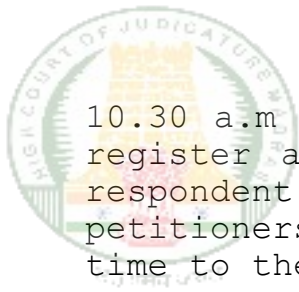
for Anticipatory Bail in Crime No.Not Known of 2019 on the
