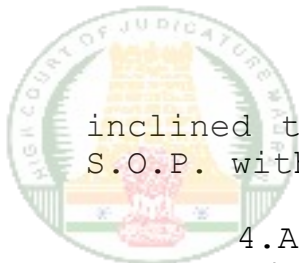

ORDER

This Civil Revision Petition is filed to direct the learned Subordinate Judge, Thiruchirappalli to dispose of S.O.P.No.25 of 2012 within a time frame.

2.The learned counsel appearing for the revision petitioner would submit that the said S.O.P.is pending from 12.10.2012. Further, referring to the Judicial Notification No.C-5 CAS/2007, Tamil Nadu (Case Flow Management in Subordinate Courts) Rules, 2007, the learned counsel contended that the case of the petitioner would be disposed of within a period of 9 months. Hence, the petitioner is before this Court with the present Civil Revision petition for issuance of a direction to the Court below for the disposal of S.O.P. at the earliest point of time.
