4. In the above circumstances, the respondent police are directed to provide effective police protection for the temple festival on 12.09.2019 and 13.09.2019 at Arulmighu Sri Sudalai Madasamy Thirukovil, Manoor, Tirunelveli District.

5. These Writ Petitions stand disposed of with the above direction. However, there shall be no order as to costs.
