PRAYER :- This Miscellaneous Petition is filed under Section 482 of Cr.P.C., praying to relax the condition imposed upon the petitioner in Crl.M.P.(MD) No.6272 of 2019 in Crl.OP(MD) No.6060 of 2019 by order dated 25.07.2019.

Prayer in CRL MP(MD). 6272/ 2019 : This Miscellaneous Petition is filed under Section 482 of Cr.P.C., praying to relax the condition imposed upon the petitioner in Crl.M.P.No.4908/2019 in Crl.O.P.No.6060/2019 by order dated 11/06/2019.

Prayer in CRL OP(MD). 6060/ 2019 : This Criminal Original Petition is filed under Section 439(1)(b) of this Cr.P.C., praying to set aside the order passed by the lower court in Crl.MP.No.288 of 2019 in C.C.No.11 of 2017 dated on 26.03.2019 on the file of Additional Chief Judicial Magistrate, Kumbakonam for the reasons stated and to relax the condition imposed by Additional Chief Judicial Magistrate, Kumbakonam in Crl.Case No.114 of 2005.



ORDER : The Court Made the following order :-

This petition has been filed to relax the condition imposed on the petitioners in CRL OP(MD). No.6060 of 2019.

2. Though the allegations made against the petitioner is serious, the fact remains that the investigation has been completed and the final report has been filed. Of course, the final report is yet to be taken on file. The petitioner is a suspended police officer. Therefore, the question of absconding will not arise. Hence, the condition imposed on the petitioner is totally relaxed and the criminal miscellaneous petition stands allowed.
