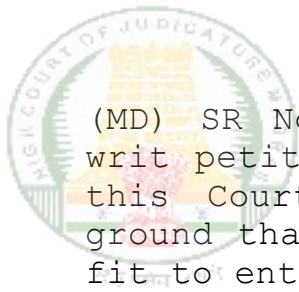

(MD) SR No.4518/2019, the petitioner has to file an independent writ petition and work out her remedy. The direction was given by this Court while rejecting the Habeas Corpus Petition on the ground that it is not maintainable. Therefore, we do not deem it fit to entertain this contempt petition.
