Heard Mr.S.Xavier Rajini, learned counsel appearing for the petitioners, Mr.K.Chellapandian, learned Additional Advocate General assisted by Mr.A.K.Baskara Pandian, learned Special Government Pleader appearing for the respondents 1, 3 to 6 and Mr.G.Rajendiran, learned counsel appearing for the second respondent.

2.The petitioners seek for inclusion of their name in the Voters list, which has been deleted and the second respondent viz., the Election Officer has published final Voters list on 05.09.2019. This is being challenged in these writ petitions.

3.The petitioners are before wrong forum as this Court cannot entertain these writ petitions with regard to deletion of persons name in the Voters list as the election process has commenced.

4.Therefore, these writ petitions are dismissed as not maintainable. However, we leave it open to the petitioners to work out their remedies in accordance with law before the appropriate



forum. No Costs. Consequently, connected miscellaneous petitions are closed.
