This Criminal Original Petition has been filed to quash the charge sheet dated 28.07.2014, made in C.C.No.276 of 2014, on the file of the learned Judicial Magistrate, Tiruchendur, Tuticorin District.

2.Today, when the matter was taken up for hearing, the learned Government Advocate (Crl. side) appearing for the first respondent, on instructions, submitted that already the trial has been commenced and eight witnesses have been examined by the Judicial Magistrate. He further submitted that the matter is posted for examination of the Investigating Officer
