(2) That the Appellant/Transport Corporation be and hereby is directed to deposit the amount awarded by the Court below, along with interest after deducting the amount already deposited if any, within a period of four weeks from the date of receipt of a copy of the judgment;

(3) That on such deposit being made, the claimants be and are hereby permitted to withdraw the award amount as per order of the Court below; and

(4) That there be no costs in this Civil Miscellaneous Appeal.
