Mr.R.Anandharaj, learned Additional Public Prosecutor takes notice for R1 to R4. Issue notice to R5 and R6 returnable by 24.09.2019. Private notice is also permitted.

2.Post the matter on 24.09.2019.

3. In the meantime, the 4th respondent is directed to inspect the petitioner's Wind Energy System situated at Survey Nos.1098 /1, 1098/2, 713/3A and 713/3B at Umarikottai Village, Tuticorin Taluk, Tuticorin District and find out

i) whether the Wind Energy System is switched off or not?

ii) whether the said Wind Energy System has access from the main road?
