PRAYER in Crl.M.P.(MD)No.7928 of 2019:-

to extend the time granted to comply with the conditions in the order passed by this Honble Court in CRL.OP(MD) No.5836 of 2019 dated 24.04.2019.

PRAYER in Crl.M.P.(MD)No.7929 of 2019:-

To modify the condition 6(a) imposed in the order made in Crl.O.P.(MD)No.5826 of 2019 dated 24.04.2019 on the file of this Court.

ORDER : The Court Made the following order :-

The petitioner is figuring as first accused in Crime No.190 of 2019 on the file of the Tenkarai police station, Theni. The offences are under Sections 171(G), 501(1)(b) of I.P.C. and Section 66 of Information Technology(Amendement) Act 2008 INF C.

2. The petitioner moved this Court seeking anticipatory bail. While granting anticipatory bail, this Court had directed the petitioner to take a Demand Draft for a sum of Rs.1,00,000/- and hand over the same to the Headmaster, Bodi Municipality Middle School, Bodi. The petitioner in view of his economic condition, is unable to comply with the said condition. The petitioner has only posted some offending messages in Face Book against the rival political functionaries.

3. Taking note of the economic condition of the petitioner, the condition earlier imposed is deleted. Time for surrender is extended by two more weeks from today. These petitions are allowed.
