Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the 1st respondent to conclude the Appeal proceedings in ந.க.மே.மு.மனு சி4/29527/2007 on his file, of the petitioner for enhanced compensation of the acquired lands to an extent of 841 Sq.Mt in S.F.No. 178/4A, an extent of 1080 Sq.Mt in S.F.No.178/5A and an extent of 443 Sq.Mt in S.F.No.178/6A of Adhavathur (East), Srirangam Taluk, Trichy District within time frame fixed by this Court.

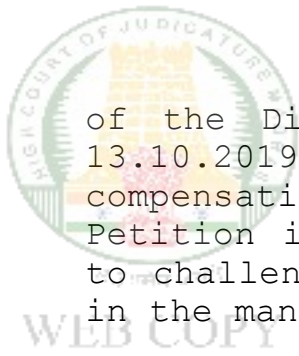
