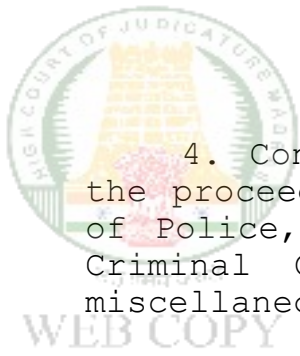

O R D E R

This petition has been filed to quash the F.I.R. in Crime No.9 of 2018 on the file of the first respondent on the complaint lodged by the second respondent.

2.The learned Counsel appearing for the petitioner would submit that the petitioner got married with the victim and due to their wedlock, she conceived and admitted in the hospital for treatment. While she was taking treatment, the second respondent thought that the aged of the victim is 17 years and lodged a complaint. Now the petitioner and the victim girl are living together and gave birth to a child. Therefore, there is absolutely no purpose to be served in continuation of investigation.

3. Today, the petitioner and the victim girl are present before this Court. They got married and also gave birth to a child and they are living together. Therefore, pending investigation would not serve for any purpose.



4. Considering the above facts and circumstances of the case, the proceedings in Crime No.9 of 2018 on the file of the Inspector of Police, All Women Police Station, Colachel, is quashed and the Criminal Original Petition is allowed. Consequently, connected miscellaneous petition is closed.
