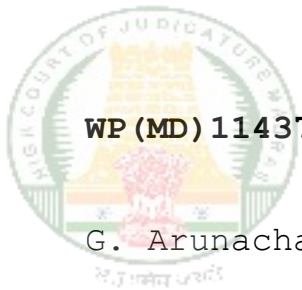

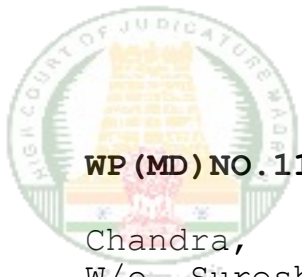

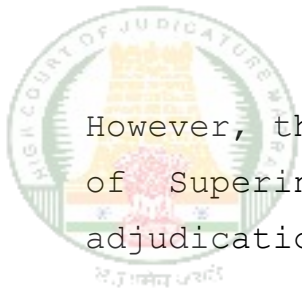

COMMON ORDER

All these writ petitioners have filed these writ petitions claiming promotion to the post of Superintendent in the Department of Treasuries and Accounts.

2.The learned counsel appearing on behalf of the writ petitioners fairly made a submission that all these writ petitioners were already promoted to the post of Superintendent during the year 2016 and now, they are working as Superintendent. However, there are certain discrepancies in the matter of grant of promotion during the year 2013 and the writ petitioners have to redress their grievances in the matter of seeking promotions on par with their juniors if they have already been promoted. This Court is of the considered opinion that if at all any such grievances exist with reference to particular junior or otherwise, it is left open to the writ petitioners to redress the same in the manner known to law.



However, the writ petitioners have already been promoted to the post of Superintendents and now working and therefore, no further adjudication is required in these writ petitions.
