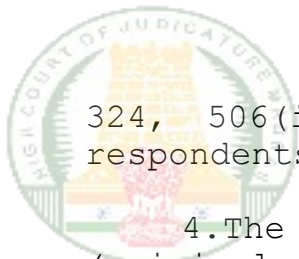

3.The learned Government Advocate (crl.side) appearing for the respondent police submitted that based on the complaint, given by the petitioner, a case has been registered by the second respondent in Crime No.201 of 2019 for the offences under Sections 294(b),
