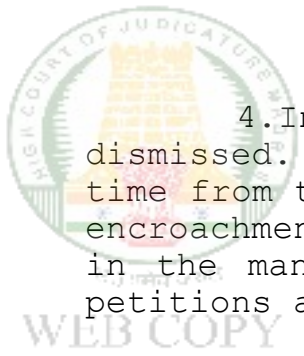
O R D E R

4.In the light of the above, this Writ Petition stands dismissed. No costs. However, the petitioner is granted eight weeks time from the date of receipt of a copy of this order, to remove the encroachment, failing which, the respondents shall remove the same in the manner known to law. Consequently, connected miscellaneous petitions are closed.
