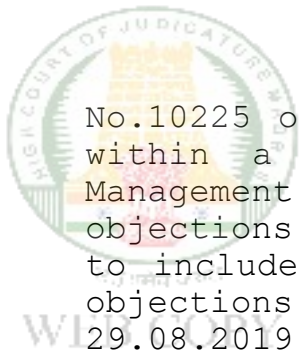

4.Considering the said facts, the second respondent is directed to consider the objections raised by the petitioner before finalising the voters list. The second respondent shall complete the election within a period of two months from today.
