PRAYER :-

Recording the said undertaking given by the petitioners herein, the impugned proceedings in C.C.No.166 of 2014 on the file of the Judicial Magistrate No.II, Karur District, stand quashed as far as the petitioners are concerned. The Criminal Original petition stands allowed. Consequently, connected Miscellaneous petition is closed.
