3.Recording the above submission made by the learned counsel for the petitioners and also the agreement dated 19.01.2019, this Criminal Original Petition is allowed and the F.I.R in Crime No.150 of 2018 pending on the file of Inspector of Police, Kaliyakkavilai Police Station, Kanyakumari District, is hereby quashed. The petitioners shall jointly pay a sum of Rs.5000/-, as costs, to the credit of the Hon'ble Chief Justice Relief Fund,
