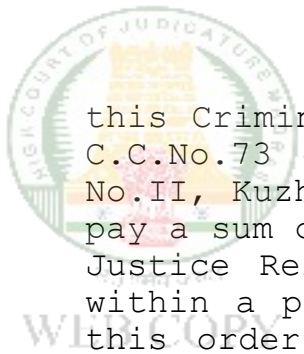

ORDER

This Criminal Original Petition has been filed to quash the charge sheet in C.C.No.73 of 2018 on the file of the learned Judicial Magistrate No.II, Kuzhithurai.

The petitioners shall jointly pay a sum of Rs.5000/-, as costs, to the credit of the Hon'ble Chief Justice Relief Fund, Madurai Bench of Madras High Court, Madurai, within a period of one week from the date of receipt of a copy of this order and file a photocopy of the receipt along with a memo reporting compliance in the Registry. Consequently, connected Miscellaneous Petitions are closed.
