### **O R D E R**

This Habeas Corpus Petition has been filed by the father of the detainee, on the ground that the 2<sup>nd</sup> respondent police have taken the illegal custody of the detainee Vairamani and thereafter, there was absolutely no reply with regard to the whereabouts of the detainee. Therefore, the present Habeas Corpus Petition has been filed before this Court, seeking to produce the body of the detainee.

2. The learned Additional Public Prosecutor appearing for the respondents, on instructions, submitted that the son of the petitioner is involved in a crime, which is the subject matter of the investigation in Crime No.940 of 2019, for an offence under Section 392 of IPC r/w 397 and 506(ii) of IPC. In the said case, the detainee was arrested and remanded to judicial custody by an order, dated 18.09.2019, and presently, the detainee is confined at Central Prison, Trichy.



3. In view of the fact that the detinue has been remanded to judicial custody pursuant to an order passed by the Magistrate, there is no question of any illegal custody of the detinue.

4. Recording the submission made by the learned Additional Public Prosecutor, this Habeas Corpus Petition is closed.
