Prayer in CRL OP(MD). 12395/ 2019 :

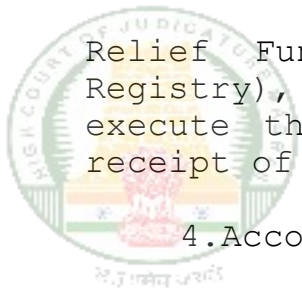
