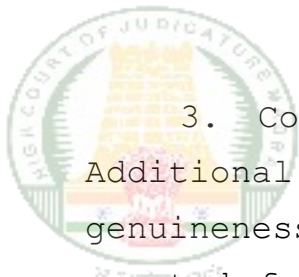

ORDER : The Court Made the following order :-

While disposing of Crl.O.P.(MD)No.14753 of 2019, this Court has given a direction to the trial Court to conclude the case on merits and in accordance with law within a period of three months from the date of receipt of a copy of that order. The order was passed on 18.10.2019.

2. Now the learned Judge, I Additional Special Court for NDPS Act Cases, Madurai has addressed a letter dated 29.03.2021 stating that the case is posted for defense witness. He is holding full additional charge of I Additional Special Court for NDPS Act cases and II Additional Special Court for NDPS Act cases, Madurai and also holding full additional charge of Chairman, Permanent Lok Adalat, Madurai. He seeks further two months time for disposal of the case.



3. Considering the reasons stated by the learned Judge, I Additional Special Court for NDPS Act Cases, Madurai and finding the genuineness of the reasons stated, three (3) months further time is granted for disposal of the case on merits and in accordance with law, from the date of receipt of a copy of this order.
