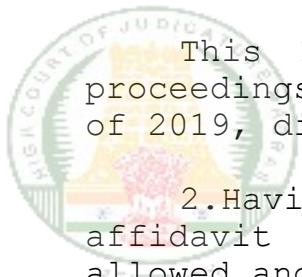
Prayer in CONT P(MD). 670 of 2019 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus to call for the records of the impugned proceedings in Na.Ka.NO.25114/C2/2014 dated 07.08.2014 on the file of the 2nd respondent and quash the same and consequently direct the Respondents to appoint the petitioner as college librarian under the UGC Norms with retrospective effect along with all time scale benefits applicable to the said post.
