When the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that as per the order dated 21.12.2018, in Crl.OP(MD)No.3677 of 2019, the Deputy Superintendent of Police conducted investigation whether one Manikandan is involved in the crime or not in Crime No.386 of 2018 and he found that the above said Manikandan was not involved in the crime. Accordingly, closed the investigation and filed a final report before the concerned Magistrate. Therefore, there is no
