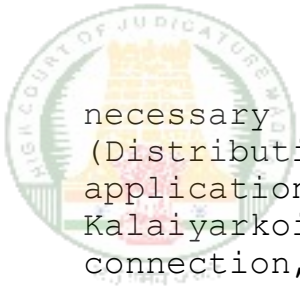

ORDER

The petitioner is the owner of a tiled house bearing Door No.2/280 at Sarukani, Devakottai Taluk, Sivagangai District. She applied for electricity service connection to the respondent. The respondent, by letter dated 01.10.2019, has communicated that the petitioner's application was returned stating that it should be submitted in complete form along with revenue documents required by the respondent. Aggrieved over the same, the petitioner is before this Court.

2. According to the learned Standing Counsel appearing for the respondent, the petitioner has to apply through online and submit documents before the Assistant Engineer (Distribution), Kalaiyarkovil Division. If the application is submitted in proper format, they are willing to process the same.

3. Considering the submission made by the parties, a direction is given to the petitioner to submit the application in prescribed format through online along with necessary charges and also submit



necessary revenue documents to the Assistant Engineer (Distribution), Kalaiyarkoil Division, forthwith. On receipt of such application in complete form, the Assistant Engineer (Distribution), Kalaiyarkoil Division, shall consider provision of service connection, within a period of four weeks thereafter.
