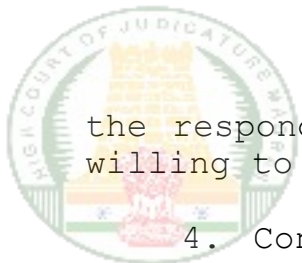

2. Heard the learned Counsel appearing for the petitioner and the learned Government Advocate (crl. Side) appearing for the respondent Nos.1 & 2.

3. The learned Government Advocate (crl. Side) appearing for



the respondent Nos.1 & 2 submitted that the respondents -1 & 2 are willing to provide police protection as requested by the petitioner.

4. Considering the submission made by the learned Government Advocate (crl. Side), the first respondent is directed to provide adequate police protection to the petitioner and also grant permission to conduct the "Purattasi Festival" in Arulmigu Sri Vada Kasi Amman Thirukovil, Ariyanayagipuram on 09.10.2019 and 16.10.2019 in the light of the earlier order of this Court dated 15.02.2019 passed in W.P.(MD) Nos. 3403 & 2924 of 2019 forthwith.

5. The writ petition stands disposed of with the above directions. However, there shall be no order as to costs.
