ORDER

Detailed submissions advanced by learned counsel appearing for the petitioner as well as learned Government Advocate have been heard.

2. The issue in question is whether Tamil Nadu Act 27 of 2011 is applicable only with effect from the date of its notification, ie., 01.04.2012 or even retrospectively.

3. Learned counsel concur on the position that the identical question as before me has been considered by a learned Single Judge of this Court in the case of *Tvl. Shanmugamari Timbers vs. Commercial Tax Officer* in *W.P. (MD) No. 3744 of 2015*, dated 20.12.2018 and held in favour of the assessee. Relying upon the judgment of the Constitutional Bench of the Supreme Court in the case of *Commissioner of Income Tax (Central) - I, New Delhi vs.*



Vatika Township Private Limited (2015 1 SCC 1) and the discussion therein on the principles governing retrospectivity of provisions, the amendment in question has been held to be retrospective. Learned Government Advocate also fairly confirms that the decision dated 20.12.2018 has attained finality.
