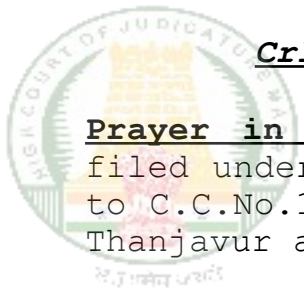

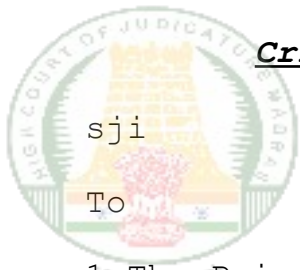
2.Recording the same, these Criminal Original Petitions are dismissed as withdrawn. Consequently, connected miscellaneous petitions are closed.
