Prayer in WMP(MD) . 7809/ 2017 :

To Stay the further operation of the impugned proceedings ந.க.எண்; ஆ2/3680/2016 dated 19.04.2017 till the disposal of the Writ Petition and thus render justice.

Prayer in WP(MD) . 10137/ 2017 :
