O R D E R

This petition has been filed seeking a direction to the first respondent Commissioner of Police to appoint the independent officer other than the 2nd respondent and to investigate and to file a final report in Crime No.232 of 2018, dated 10.12.2018 on the file of the Traffic Investigation Wing (TIW) North Police Station, Trichy, Trichy District.

2. The learned counsel for the petitioner would submit that the petitioner is a father of the deceased. The deceased was driving a two wheeler namely, Apache Yellow Colour bearing Registration No.TN-75-B-1467 from Chennai to Trichy, he was dashed

died in the spot on 10.12.2018. The second respondent police registered an F.I.R. on 10.12.2018, in Crime No.232 of 2018 for the offences under Sections 279 and 304 of IPC. Unfortunately, till today the second respondent did not find out the accused and the investigation is still pending.
