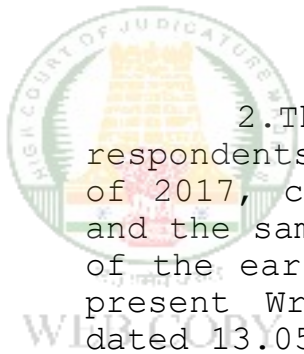

ORDER

The order of the fourth respondent dated 13.05.2016 is sought to be quashed in the present Writ Petition and further direction is sought for to direct the fourth respondent to reinstate the petitioner as Sweeper with all back wages and service benefits.

4.In view of the same, this Writ Petition stands dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
