O R D E R

This Criminal Original Petition has been filed to direct the second respondent to provide adequate police protection for fencing the property, based on the representation, dated 27.06.2019.

2. Based on a complaint lodged by the petitioner, dated 27.06.2019 against the respondents-3 to 7, the respondent police has conducted enquiry and closed the same. The enquiry reveals that the properties are belongs to the petitioners which was in their peaceful possession and enjoyment of the said property.
