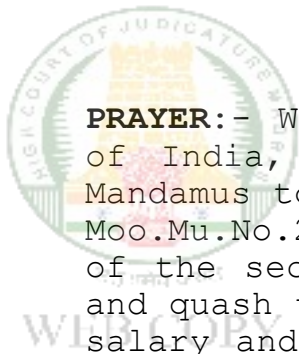

**COMMON ORDER**

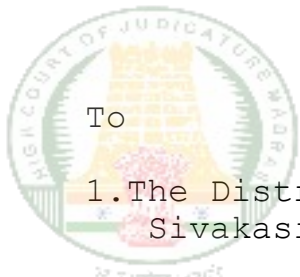
