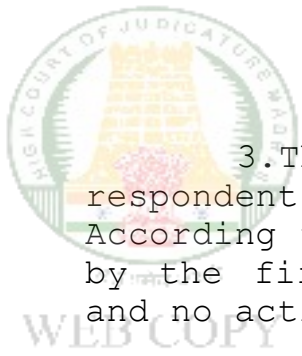

By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

2.Heard Mr.PT.S.Narendravasan, learned Counsel appearing for the petitioner and Mr.Aayiram K.Selvakumar, learned Additional Government Pleader appearing for the first respondent.



3.The petitioner seeks for a direction upon the first respondent to implement the proceedings dated 29.07.2019. According to the petitioner, in spite of notice having been issued by the first respondent construction is going on unauthorisedly and no action has been initiated to remove the encroachment.

4.Mr.Aayiram K.Selvakumar, learned Standing Counsel appearing for the first respondent, on instructions, submitted that notice has been issued to the second respondent and construction has been stopped and action has been taken for removal of encroachment, for which purpose measurement is to be undertaken and the matter will be expedited and action will be initiated within four [4] weeks from today.

5.This submission made on behalf of the first respondent is placed on record and the entire process should be completed within a period of four [4] weeks.

6.The Writ Petition stands disposed of, accordingly. However, there shall be no order as to costs.
