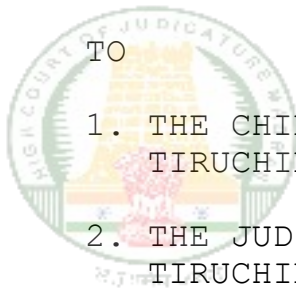
3.There is no objection on the side of the petitioner in extending the time limit.
