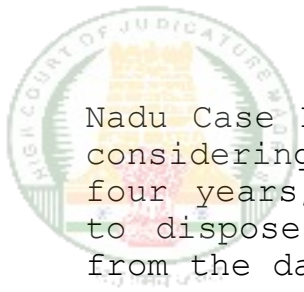
ORDER

This Civil Revision Petition has been filed by the revision petitioners, seeking a direction to the learned District Munsif, Karur, for early disposal of O.S.No.549 of 2014, within a stipulated period.

2. The learned counsel appearing for the revision petitioners submitted that the revision petitioners filed a suit in O.S.No.549 of 2014 before the learned District Munsif, Karur, for declaration. But, the said suit is pending for more than four years. The learned counsel further submitted that as per the Judicial Notification No.C-5 CAS/2007 Tamil Nadu Case Flow Management in Subordinate Courts/Rules 2007, the said suit should be disposed of within a period of two years from the date of filing. But, the same is pending for more than four years. Hence, the present Civil Revision Petition has been filed seeking a direction to the learned District Munsif, Karur, for early disposal of O.S.No.549 of 2014, within a stipulated period.
