2.The learned Additional Public Prosecutor would submit that the case in C.C.No.444 of 2013 pending before the District Munsif cum Judicial Magistrate, Eraniel is transferred to the learned Fast Track Court Judge, Eraniel and renumbered as C.C.No.632 of 2019.
