When the matter is taken up for hearing today, the learned Additional Public Prosecutor would submit that based on the complaint given by the petitioner, the third respondent along with other officials visited the quarry sites and also caused inspection with regard to the illegal quarry made in the quarry site. Pursuant to the inspection, the third respondent/The District Collector, Sivagangai has issued show cause notice under Section 36 (5) (H) of the Tamil Nadu Mines and Minerals Concession Rules, 1959.

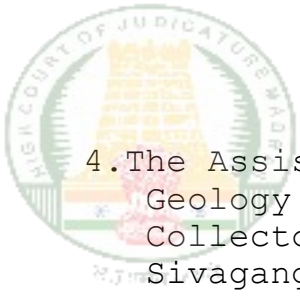
