Order: This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.K.GUHAN, Advocate for the petitioner, and of Mr.A.THIRUVADIKUMAR, Advocate for the respondent, the court made the following order:-

The learned counsel for the petitioner represented that this Court granted suspension of sentence on 24.10.2019 with certain conditions as such one of the condition is that the petitioner was directed to deposit a sum of Rs.2,00,000/- (Rupees Two lakhs only) within a period of six weeks. But the petitioner has not comply with the condition till date.

2.The learned counsel for the respondent has not disputed the above fact.

3.Hence, suspension of sentence granted by this Court in Cr1.M.P(MD)No.9192 of 2019 in Cr1.R.C(MD)No.797 of 2019 is dismissed.
