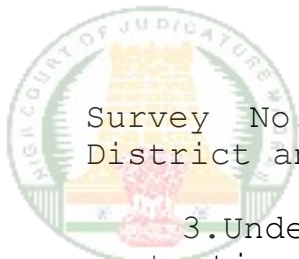

This Criminal Original petition has been filed to direct the respondents to give adequate Police protection for the Petitioner in order to survey the lands in S.
